Who are we?

TRT is a registered charity founded in 1986 and is part of The Rivers Trust movement, we are the Hub Trust for the Thames catchment, with our partners we are dedicated to improving the Thames and its tributaries for the benefit of people, wildlife and the environment.

TRT is committed to developing a collaborative, partnership approach that maximises the benefits of public, private and third sector organisations working together with communities to deliver integrated outcomes. Our most recent flagship project was the successful Thames Catchment Community Eels Project.

TRT administers The Thames Catchment Forum. The forum brings together catchment partnership hosts within the Thames Catchment and additional stakeholders to receive updates from Thames Water and the Environment Agency and discuss generic issues and propose solutions.

Working in partnership, including sharing knowledge and expertise at meetings or creating and developing projects to restore or improve rivers as well as educating and including local communities, means we can work together and achieve more.

Rivers are vital, for communities and for a wealth of wildlife species; yet they are facing a multitude of serious threats and challenges. Together we and our partners are striving at many levels to preserve and improve rivers now and for the future in the Thames catchment.

What is a Trustee?

Charity Trustees are the people who share ultimate responsibility for governing a charity and directing how it is managed and run. Some charity trustees see their role as turning up to 4 meetings a year, but engaged trustees do a lot more than that.

Our Trustees use their skills, knowledge and experience to support TRT, helping the charity achieve its aims. Trustees also often learn new skills during their time on the board.

Our board of Trustees meet up quarterly in person, during the day in London, along with the CEOs of our partner organisations. In between these meetings trustees are in touch on an ad-hoc basis with our small, but dedicated team (through email, Zoom and telephone).
